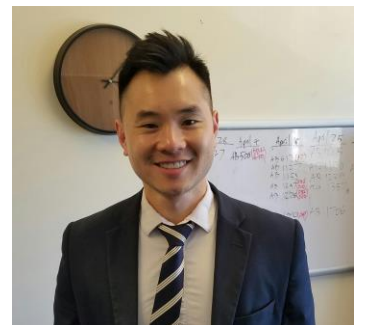


Dr. Le Ondra Clark Harvey, Chief Consultant - Dr. Clark Harvey joined the Assembly Committee on Business and Professions in 2015. Price, Jr. She was a social justice fellow at the Center for Policy Analysis in San Francisco. Prior to her employment in the Legislature, she practiced for 6 years as a Licensed Professional Counselor in Madison, Wisconsin.

Dr. Clark Harvey completed her Ph.D. and M.S. in Counseling Psychology at the University of Wisconsin, Madison. She completed her pre-doctoral fellowship at the University of Southern California Children's Hospital Los Angeles and a post-doctoral fellowship at the University of California, Los Angeles Mattel Children's Hospital.
